**Fee Schedule of Expected Total Fees and Estimated Expenses**

**I. Fees For Services Provided by Sunny Ridge and Paid in the U.S.**

<b>Application fee</b> (non-refundable) .....	\$250
<i>Payment to Sunny Ridge Family Center due with application</i>	
<b>Initial home study fee</b> .....	\$2,850
<i>Payment to Sunny Ridge Family Center due at first session of home study*</i>	
<b>Subsequent home study fee</b> (for a subsequent adoption when Sunny Ridge completed first home study) .....	\$2,050
<i>Payment to Sunny Ridge Family Center due at first home study session*</i>	
<b>Home study update fee, required annually and for significant changes</b> .....	\$500
<i>Payment to Sunny Ridge Family Center due at time service provided</i>	
<b>Required pre-home study educational session</b> .....	\$100
<i>Payment to Sunny Ridge Family Center due at time service provided</i>	
<b>Agency's program fee</b> .....	\$9,300
<i>Covers dossier oversight, ongoing case management, communications with governmental agencies and foreign entities, administrative overhead, operational costs, personnel costs, translation/processing of referral documents, post adoption report translation/processing, and support services rendered in the U.S. and China.</i>	
<i>Payment due to Sunny Ridge Family Center in two installments as outlined below</i>	
<b>\$5,000 due at time of dossier submission</b>	
<b>\$4,300 due at time of referral acceptance (\$5,800 when accepting two referrals at the same time)</b>	
<b>Post adoption visit and report fee( Includes express mailing fee to China)</b> .....	\$375
<i>(\$175 each additional child.) Payment to Sunny Ridge Family Center due at each visit.</i>	
<i>(number of visits depends on China Center For Children's Welfare &amp; Adoption requirements)</i>	
<b>Final Court Report</b>	
● <b>If interim order presented by the one-year post adoption visit</b> .....	\$0
● <b>If interim order presented after one-year post adoption visit</b> .....	\$350
<i>A visit will be required. Payment to Sunny Ridge Family Center due at time of visit</i>	
<b>Consultation fee – per hour</b> (applied to home study fee if apply to SRFC program) .....	\$100
<i>Payment to Sunny Ridge Family Center due at time of consultation</i>	
<b>Travel outside a 50-mile radius of SRFC</b> .....	\$75 hourly charge

**Out of State/Country Background Check Fee - paid directly to state/country**

<b>Fingerprinting fee per adult</b> (required for each adult in the home, age 17 and older) .....	fee varies
<i>Payment due at submission of background check form to state/country</i>

<b>CCAA application fee</b> .....	\$480
<i>Payment due with submission of dossier</i>	
<b>CCAA document translation fee</b> .....	\$150
<i>Payment due with submission of dossier</i>	
<b>CCAA Processing Fee</b> .....	\$80
<i>Payment due at time of signing referral acceptance papers</i>	

**U.S. Citizenship and Immigration Service Fees paid directly to CIS**

- I-800A** (valid for 15 mos. – re-filing may be required) .....visit [www.uscis.gov](http://www.uscis.gov) for current fee  
*Payment due at time of submission of 800A to USCIS*
- Fingerprinting fee per adult** (required for each adult in the home, age 18 and older  
Valid for 15 months, may require reprinting) .....visit [www.uscis.gov](http://www.uscis.gov) for current fee  
*Payment due at time of fingerprinting to US CIS*

**Secretary of State/Chinese Consulate Fees**

- Dossier documents sealed by jurisdictional state and Chinese Consulate** ..... \$315  
*Payment due at time of sealing documents to Sec. of State and Chinese Consulate  
(Based on average of 14 documents)*
- Parents' visa fees (\$130 each)** ..... \$260  
*Payment passed through Sunny Ridge Family Center to Chinese Consulate due prior to travel*

**Express Mailing Fees will be billed to family at time of service**

**III. Third Party Fees Paid in China**

*All third party fees are set by other entities and subject to change without notice*

- In country legal/processing fees** (average) ..... \$1,300  
*(adoption registration, notary fee, passport, pictures)  
Payment due to provincial government at time of adoption proceedings*
- Welfare institute donation** ..... (Approximate Conversion to USD) \$5,100  
*Payment due to provincial government at time of adoption proceedings ..... (Payable in 35,000 RMB)*
- Child's Visa fee** ..... \$404  
*Payment due to U.S. Consulate at U.S. Consulate appointment*
- Child's Medical Exam for Visa fee** ..... \$100 to \$300  
*Payment due to clinic at time of medical exam*

**IV. Estimated Travel Expenses**

- Airfare, hotels, food, transportation (per couple)** ..... \$6000 to \$9,000  
*Based on 16 day round trip to China, coach airfare, moderate hotels, translator.  
Payment due to service providers before and during trip. Shopping not included*

**V. Estimated Adoption Preparation Training Costs ..... \$200 to \$500**

*Various training options available and payment made to training vendors*
